

ARTICLES OF INCORPORATION
OF
KARST UNDERWATER RESEARCH, INC

The undersigned acting as incorporator of a corporation pursuant to Chapter 617 of the Florida Statutes, adopts the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation shall be:
Karst Underwater Research, Inc.

Hereafter, in this document, referred to as KUR.

ARTICLE II

The address of the principal office and mailing address will be:

ARTICLE III

KUR is organized and operated exclusively for research and educational purposes within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986.

KUR engages in exploration of water or air filled subterranean environments and provides geological survey information, which may include (but not be limited to) maps, video images, photographs, water samples, biological/organic samples, and mineral/water samples from said subterranean environments for parties with the authority to engage KUR in such activities. Promulgated information will be made available to all interested parties at cost of production.

KUR will also endeavor to acquire title to real property on which such subterranean environments exist in order to preserve the property in its natural condition for future generations.

No part of the net earnings, gains, or assets of KUR shall inure to the benefit of or be distributable to its directors, officers, other private individuals, or organizations organized and operated for a profit (except that KUR shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes as hereinabove stated).

No substantial part of the activities of KUR shall be the carrying on of propaganda or otherwise attempting to influence legislature, and KUR shall be empowered to make the

election authorized under section 501(h) of the Internal Revenue Code of 1986. KUR shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provisions herein, KUR shall not carry on any activities not permitted to be carried on --

(a) by an organization exempt from federal income taxation under section 501(a) of the Internal Revenue Code of 1986 as an organization described in section 501(c)(3) of such Code, or

(b) by an organization, contributions to which are deductible under sections 170(c)(2), 2055(a)(2), or 2522(a)(2) of the Internal Revenue Code of 1986

References herein to sections of the Internal Revenue Code of 1986 are to provisions of such Code as those provisions are now enacted or to corresponding provisions of any future United States revenue law.

In the event of dissolution or final liquidation of KUR, the board of directors shall, after paying or making provisions for the payment of all the lawful debts and liabilities of KUR, distribute all the assets of KUR to one or more of the following categories of recipients as the board of directors of KUR shall determine: to a nonprofit organization or organizations having similar aims and objects as KUR and which may be selected as an appropriate recipient of such assets, as long as such organization or each of such organization shall then qualify as governmental unit under section 170(c) of the Internal Revenue Code of 1986 or as an organization exempt from federal income taxation under section 501(a) of such Code as an organization described in section 501(c)(3) of such Code.

ARTICLE IV

The manner in which the directors are to be determined is provided for in the bylaws for KUR.

ARTICLE V

There are no provisions which limit corporate powers authorized under section 617.0302, Florida Statutes other than the provisions noted in ARTICLE III.
